

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to Gigpromoter, and Gigpromoter LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Gigpromoter LLC include [www.gigpromoter.com](http://www.gigpromoter.com) and Gigpromoter. The Gigpromoter application is a web & mobile event-promotion skills-training, team-development & task-management application. By using the Gigpromoter application, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered, Gigpromoter may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Any other contact information or other content of any kind entered in any form or input

If you purchase Gigpromoter's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

### **Use of your Personal Information**

Gigpromoter collects and uses your personal information to operate and deliver the services you have requested.

Gigpromoter may also use your personally identifiable information to inform you of other products or services available from Gigpromoter and its affiliates.

### **Sharing Information with Third Parties**

Gigpromoter does not sell, rent or lease its customer lists to third parties.

Gigpromoter may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Gigpromoter may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Gigpromoter, and they are required to maintain the confidentiality of your information.

### **Right to Deletion**

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to:

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Right of Correction**

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Correct your personal information in our records; and
- Direct any service providers to correct your personal information in their records.

Please note that we may not be able to comply with requests to correct your personal information if it is necessary to:

### **Children Under Thirteen**

### **E-mail Communications**

From time to time, Gigpromoter may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communication. In order to improve our Services, we may receive a notification when you open an email from Gigpromoter or click on a link therein.

If you would like to stop receiving marketing or promotional communications via email from Gigpromoter, you may opt out of such communications by cancelling reminder emails through their user account, or clicking "Unsubscribe" in any promotional or marketing email.

### **External Data Storage Sites**

We may store your data on servers provided by third party hosting vendors with whom we have contracted.

### **Changes to this Statement**

Gigpromoter reserves the right to change this Privacy Policy from time to time. We will notify you about significant changes in the way we treat personal information by sending a notice to the primary email address specified in your account, by placing a prominent notice on our application, and/or by updating any privacy information. Your continued use of the application and/or Services available after such modifications will constitute your: (a) acknowledgment of the modified Privacy Policy; and (b) agreement to abide and be bound by that Policy.
